The first dividend following the Offer is expected to be paid in April 2014.

Instalment

Receipts

Pay for Shares in two instalments. Get dividends in full.

How does the instalment payment process work?

- You will have been issued with an Instalment Receipt for each Share that you have partially paid for.
- The Shares that relate to those Instalment Receipts are held by one of the Trustees on trust pending payment of the Final Instalment.
- After you pay the Final Instalment, the Shares held by the Trustee are transferred to you and the related Instalment Receipts are cancelled.
- If you do not pay the Final Instalment when it is due, the Trustee may sell the Shares that relate to those Instalment Receipts.

What rights do Instalment Receipt holders have?

As a holder of Instalment Receipts, you have rights similar to holders of Shares. You will be:

- entitled to receive any dividends paid by Meridian on the Shares, together with any imputation credits
- invited to attend shareholder meetings of Meridian
- entitled to instruct the relevant Trustee how to vote at shareholder meetings of Meridian
- entitled to receive Meridian's annual and interim reports, and other Meridian shareholder communications
- entitled to sell your Instalment Receipts, which are quoted on the NZX Main Board and the ASX.

When is the Final Instalment due?

- The Final Instalment will be payable by 15 May 2015.
- If you sell your Instalment Receipts before the record date for determining payment of the Final Instalment (4 May 2015) you will not be responsible for paying the Final Instalment.
