If your investments are held on behalf of another person, trust or entity, then provide the IRD number for that person, trust or entity. If your IRD number has not been recorded by Computershare, this may result in RWT being deducted from your interest payments at a different rate to your rate as determined by the tax rules set by the New Zealand Inland Revenue Department.

If you are exempt from RWT, please tick the appropriate box and provide the date of expiry (if applicable). Please note all tax exemptions will be electronically verified with the IRD.
